### **Purpose:**

The Mary Ciuniq Pete Legacy Scholarship was created to honor the legacy of late KuC director Mary Ciuniq Pete. The scholarship is housed at Bethel Community Services Foundation and was created in partnership with the leadership team from the UAF-Kuskokwim Campus and Mary's partner, Hubert Angaiak. As the director of KuC and a leader in many other arenas, Mary was a fierce advocate for high-quality education, a healthy and thriving environment, and the safety of women and girls in Bethel and across Western Alaska.

The Mary Ciuniq Pete Legacy Scholarship supports KuC students with a preference given to students who are Alaska Native women. Mary deeply valued **perseverance** and **retention**. To encourage retention, the scholarship will only be available to returning students (third semester and beyond; see qualifications section). Part-time and full-time students are eligible to apply. The award may be used for tuition OR other education-related expenses. The award will be paid to UAF-KuC.

**Award:** \$1,000 will be awarded to up to three KuC students for the Fall 2024 semester. Past scholarship recipients are eligible to apply again for the scholarship. See info below about applicant eligibility requirements preferences. If three eligible students are not selected, the committee may choose to increase the scholarship amount for the one or two other awardees.

### **Eligibility Requirements:**

- a) Applicant must submit all required documentation listed on checklist (located at end of application).
- b) Applicant must have completed at least two (2) semesters for a minimum of six (6) credit hours of course work at the UAF-Kuskokwim Campus per letter (c) below. Applicant must carry a minimum of three (3) credit hours per semester to be eligible.
- c) Applicant must be a KuC student or a student enrolled in a course located at the Kuskokwim Campus. This includes YK village-based students enrolled in a distance course. These can be graduate or undergraduate courses.
- d) Applicant must submit all college transcripts.
- e) Applicant must have and maintain a cumulative GPA of 2.5 to qualify.
- f) Applicant must submit a personal statement (see below).

### **Eligibility Preferences:**

Preference will be given to Alaska Native women from or residing in a rural community in Western Alaska.

**Submission:** Applications may be received by online submission, fax, mail, email, or drop-off by Monday, May 20, 2024 at 5 pm.
